#### **Position Summary**

The **Investment Attorney** plays a central legal role in the execution and oversight of NMSIC's National Private Equity & NM Strategic Venture Capital Programs. The position is responsible for managing the end-to-end legal lifecycle of approximately 30 fund commitments annually. This includes legal due diligence, negotiation of fund terms, coordination with internal and external counsel, and ensuring legal readiness for closing.

The attorney also supports strategic initiatives related to policy development, investment infrastructure, and Council education. This includes implementing legal process automation, enhancing team communication, and contributing to broader institutional knowledge around private equity, New Mexico-specific investment mandates, and legal foundations.

This position reports to the **Private Equity Portfolio Manager** and other investment professionals.



# **Key Responsibilities**

## **Legal Review & Fund Negotiation**

- Review and analyze Limited Partnership Agreements (LPA), Private Placement Memoranda (PPM), subscription agreements, and side letters for consistency with business and legal standards.
- Ensure investments agreements reflecting the best interest of New Mexicans
- Negotiating terms that align with the state's fiduciary responsibilities.
- Lead negotiation of side letters with opposing counsel and address key legal and compliance issues.
- Engage external legal counsel for detailed LPA review and collaborate on drafting comments and proposed revisions.
- Coordinate with fund managers, external counsel, and internal investment officers to finalize terms.
- Escalate unresolved legal issues and participate in negotiation meetings with general practitioners, legal counsel, and NMSIC executives.

# **Execution & Closing**

- Prepare and review closing documentation for State Investment Council execution.
- Obtain necessary internal authorizations and ensure full legal compliance.
- Distribute final documents to custodians, internal accounting, and external parties.
